SUPPLEMENTAL INSTRUCTIONS TO FORM ST-3
FOR FILING YOUR SALES AND USE TAX RETURN

A REPORT MUST BE FILED FOR THE MONTH OR QUARTER YOU BEGIN SELLING OR PURCHASING ITEMS SUBJECT TO SALES AND USE TAX (line 25 on The State Tax Registration Application Form CRF-002).

BASED ON YOUR FILING STATUS, YOU MUST FILE A REPORT MONTHLY, QUARTERLY OR ANNUALLY. YOUR PAYMENT MUST BE RECEIVED BY THE 20TH OF THE MONTH FOLLOWING THE PERIOD FOR WHICH THE TAX IS DUE.

IF YOU HAVE RECEIVED A NEW CERTIFICATE FOR YOUR BUSINESS, FOR CHANGES SUCH AS A CHANGE OF ADDRESS OR A REQUEST FOR A DUPLICATE LICENSE, YOUR FILING STATUS WILL NOT CHANGE.

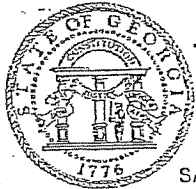
DEALERS AND CONTRACTORS MUST FILE TIMELY RETURNS EVEN IF NO TAX IS DUE.
