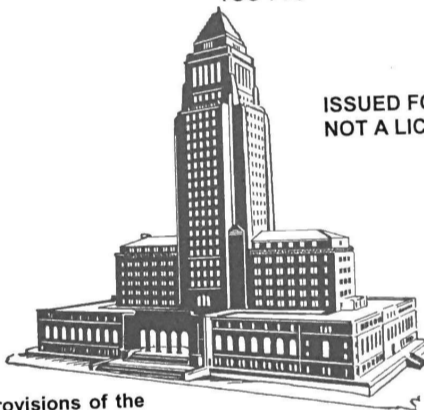

### A MESSAGE TO OUR NEW PERMIT HOLDER

**As a seller, you have rights and responsibilities under the Sales and Use Tax Law. In order to assist you  
endeavor and to better understand the law, we offer the following sources of help:**

- Attending a Basic Sales and Use Tax Law class offered at one of our field offices
- Sending your questions in writing to any one of our offices

**As a seller, you have the right to issue resale certificates for merchandise that you intend to resell. You also  
have the responsibility of not misusing resale certificates. While the sales tax is imposed upon the retailer,**

- You have the right to seek reimbursement of the tax from your customer
- You are responsible for filing and paying your sales and use tax returns timely
- You have the right to be treated in a fair and equitable manner by the employees of the California State  
Board of Equalization (BOE)
- You are responsible for following the regulations set forth by the BOE

As a seller, you are expected to maintain the normal books and records of a prudent businessperson. You are  
expected to maintain these books and records for no less than four years, and make them available for inspection by a BOE rep  
when requested. You are also expected to notify us if you are buying, selling, adding a location, or discontinuing you  
adding or dropping a partner, officer, or member, or when you are moving any or all of your business locations. If  
necessary to surrender this permit, you should only do so by mailing it to a BOE office, or giving it to a BOE represent
