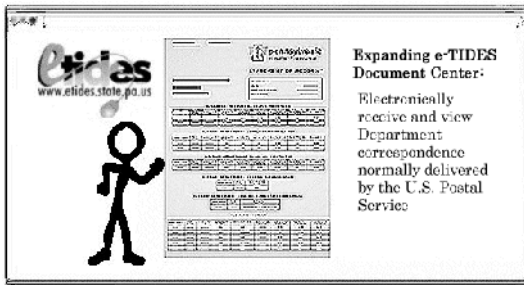

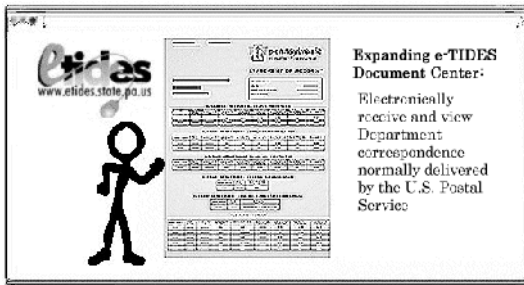

**CHANGE IN OWNERSHIP OF BUSINESS**

A change in ownership voids an account and cancellation is required. Please refer to the Permanent Discontinuance of Business section found below for instructions on how to cancel the account. A change to or from a sole proprietorship, partnership or corporate entity, or the death of a proprietor, constitutes a change in ownership. A new PA Enterprise Registration Form (PA-100) must be completed online at [www.pa100.state.pa.us](http://www.pa100.state.pa.us).

**CHANGE OF ADDRESS**

Notify the department immediately of any change to your business location or mailing address by updating your e-TIDES account or completing a Tax Account Information Change/Correction Form (REV-1705).

**PERMANENT DISCONTINUANCE OF BUSINESS**

Account holders must notify the department through e-TIDES, or by completing a Business/Account Cancellation Form (REV-1706).

**FORMS ORDERING INFORMATION**

All documents referenced herein can be downloaded from [www.revenue.pa.gov](http://www.revenue.pa.gov) or requested from the department's toll-free, 24-hour forms ordering service at 1-800-362-2050.

**ELECTRONIC PAYMENT**

All sales, use and hotel occupancy tax, employer withholding, malt beverage tax and corporation tax payments of \$1,000 or more must be remitted by electronic funds transfer (EFT). Taxpayers can make EFT payments by registering at [www.etides.state.pa.us](http://www.etides.state.pa.us) or by calling TeleFile at 1-800-748-8299.

**PAYMENT OF TAX**

Please make checks and money orders payable to the PA Department of Revenue and include on the payment your Account ID, Revenue ID, phone number and the tax period end date for which the payment is intended. Mail payments to the PA DEPARTMENT OF REVENUE, PO BOX 280404, HARRISBURG PA 17128-0404.

**COMPLIANCE**

Failure to pay liabilities may result in one or more of the following: the filing of a lien; wage garnishment; administrative bank attachment; civil legal action; loss of tax benefits; criminal prosecution; referral of your case to a collection agency where additional fees up to 39 percent of the amount due may be added to the liability; and/or suspension or loss of business licenses or privileges.

**Account Information and Requirements**

The Retailers' Information Guide (REV-717) is a resource published by the department every three years that contains descriptions of taxable services and lists of common items subject to sales, use and hotel occupancy tax. It is available on the department's website at [www.revenue.pa.gov](http://www.revenue.pa.gov).

Returns are to be filed whether or not taxable transactions occur in a period. File and remit payments using one of the following electronic options:

- **e-TIDES** - File tax returns and remit payments to the department for employer withholding tax, sales, use and hotel occupancy tax, public transportation assistance fund taxes and fees and vehicle rental taxes online using e-TIDES, a free business tax filing system available to all registered account holders. Visit [www.etides.state.pa.us](http://www.etides.state.pa.us) to register for e-TIDES.
- **TeleFile** - TeleFile provides a fast and secure way to file tax returns and remit payments of employer withholding tax, sales, use and hotel occupancy tax, public transportation assistance fund taxes and fees and vehicle rental tax by calling, toll-free, 1-800-748-8299.
- **Third-Party Vendors** - Approved third-party vendors provide for secure transmission for filing and paying employer withholding tax and sales, use and hotel occupancy tax. Visit [www.revenue.pa.gov](http://www.revenue.pa.gov) to learn more about this paperless filing option.

The due date of each return is the 20th day of the month following the end of each calendar quarter. If the due date falls on a weekend or holiday, the due date is the next business day. Due dates can also be found on Form REV-819 available at [www.revenue.pa.gov](http://www.revenue.pa.gov). Please note the discount for filing timely is not applicable to use tax.
