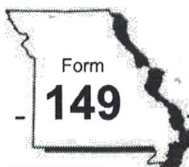

Manufacturing Partial Exemptions section with checkboxes for Research and Development, Machinery and Equipment Used, Materials, Chemicals, Machinery, and Equipment Used, and Utilities or Energy and Water Used.

Other section with checkboxes for Agricultural, Common Carrier, Locomotive Fuel, Air and Water Pollution Control, Commercial Motor Vehicles or Trailers Greater than 54,000 Pounds, and Other.
